## INFORMATION ABOUT THE SERVICE

### SERVICE DESCRIPTION and KEY INFORMATION

**1800 numbers** are 10 digit numbers where the call is free for the caller if dialled from an Australian phone line, including Australian mobiles. They are national inbound numbers and can only be used for receiving calls where the account holder is charged a call rate dependent upon its origin and where the 1800 number is being routed to. 1800 numbers offer a high level of call handling flexibility and can be routed to one or a range of answering points which can be either a landline or a mobile phone number. 1800 numbers come with included features such as Auto Attendant, Voice2Email, Business Intro Message, Geographical Routing, Time Dependent Routing, Call Alert, Call Forwarding, Call Overflow, Call Distributor and Call Barring.

### MINIMUM TERM and PLAN CHANGES

Minimum term is one (1) month. You can change your plan at any time and changes take effect from the commencement of the following billing period.
